

CURRICULUM VITAE

A. 1. Georgios Archaniotakis, born on 1951 in Malles of Ierapetra, Crete, is a graduate of the Faculty of Law and Economic Sciences of Aristotle University of Thessaloniki [degree "Honors 10"]. During his studies (1969-1973), he has been a scholar of the "State Scholarship Foundation" -as result of his high performance - and received the prize of the Bank of Greece (1973) as the student with the highest marks in all the Faculties of the Aristotle U. He has worked as unsalaried scientific collaborator of Professor Dr Constantine Kerameus from September to December 1973 but discontinued because of enlistment (involuntary) and military service from January 1974 to November 1975. He has knowledge of German and English and moderate knowledge of French language.

2. a. In October 1976 he was selected through an open competition and appointed as assistant at the then 5th Chair of Civil Law (Professor Nikos S. Papantoniou). In June 1979 he went, as a scholar of «D.A.A.D.», in Germany (Bonn, Köln) in order to complete the course in the German language but also in order to collect the basic information for the preparation of his (doctoral) dissertation. In June 1988 he was unanimously declared as Doctor of Law School of AUTH, Honours Degree by the topic: "The civil liability of a legal person governed by private law - Interpretative inclusion of article 71 Greek Civil Code in the general system of liability under the Civil Code". In July 1989 he was elected unanimously as permanent Lecturer at the School of Law of the Aristotle University of Thessaloniki, with subject area the Civil Law. During the winter semester of 1992, he was invited by Prof. Dr Harm-Peter Westermann and continued his scientific research at the Law Faculty of the University of Tübingen on the issues of transfer of Patrimonium or Enterprise. In December 1997 he was elected as Assistant Professor, in June 2002 as Associate Professor and in October 2006 as Professor (first's degree), in all that elections by unanimous decisions of the Electoral Board.

b. Since 1988 he has taught all the undergraduate fields of civil law (except Property Law) and during the last decade: General Principles of Civil Law, Law of Obligations General Part, Special Courses Deepening Civil law, Protection Leases. Since 2002 participates in postgraduate courses, inter alia directing students in the writing of their postgraduate thesis and selected by them as Supervisor Professor ("Doctor Father") or member of advisory committees for doctoral dissertations (PhD). His writing and research activity covers the entire spectrum of civil law [see appended table].

3. He has been Representative of the Faculty of Law in the Senate of AUTH for the year 1996-1997 and Director of the Department of Civil, Civil Procedure and Labour Law as well as Member of the Board of Law School (September

2011-January 2013). He has also been Representative of this Department in the General Assembly of the Law School throughout almost all years of his university's activity (1988-2013). He had the honour to be Member of the Legal Committee of AUTH (1994-2004) and legal advisor -position without payment- of the "Institute of Engineering Seismology and Earthquake Engineering" (2004-2006)
