Anthoula Papadopoulou concluded her basic education in Thessaloniki, Greece. She graduated from the Faculty of Law of Aristotle University of Thessaloniki in 1981 with the distinction “excellent”. After completing a master degree in the Aristotle University of Thessaloniki in Private Law (1985) with the distinction “excellent”, she received her Doctorial Degree in Law (Ph.D.) from the same University (1996) with the distinction “excellent” unanimously. Her thesis with the title *Author’s moral right of integrity on his work* was published by Sakkoulas Editions (Athens – Thessaloniki) in 1997.

She is a member of various scientific bodies, including the Macedonian Society of Commercial Law, the Greek Association of Commercial Law, the Association for the Protection of Copyright, which is the Greek Department of Association Littéraire et Artistique International (ALAI) based in Athens.
