He is a graduate of the University of Thessaloniki (LL.B., 1975) and Munich/Germany (LL.M 1977, Dr. iur., 1981). He has published a number of books and articles on Civil, Procedural, Comparative and Consumer Protection Law in Greek and German. He was a member of the Group of Experts which introduced Laws Nr. 1961/1991 (Consumer Protection) and 3043/2002 (Transposition of Directive 1999/44/EC of the European Parliament and of the Council of 25 May 1999 on certain aspects of the sale of consumer goods and associated guarantees). He was a member of the Council Board of the Greek Civil Law Association during the period 1999-2005 and he currently continues his activity as a member. Moreover, he is a member of the Greek Procedural Law Association, the “Gesellschaft für Rechtsvergleichung” and the Northern Greece Lawyers Association.
