- Graduated from the Classical Lyceum of Volos, Greece.

After an oral examination covering all fields of law (so called “rigorosum”) in November 2002, I was nominated Doctor of Legal Sciences (Doktor der Rechte) with distinction (“summa cum laude”). During my scientific presence in Bonn - Germany I attended courses in all fields of law, emphasizing in Commercial and Civil law (under the supervision of Prof. Ulrich Huber, Marcus Lutter, Karsten Schmidt, Wolfgang Schön, Rolf Knütel). My dissertation has been published in the series of Studies on Economic and Labor Law (Abhandlungen zum Arbeits- und Wirtschaftsrecht) - “Recht und Wirtschaft” Publications in Heidelberg.
