

## CV

Adam Papadamakis is a graduate of the Law School of AUTH. He undertook postgraduate studies in criminal law and was awarded Doctor of Laws (LL.D.) by the Department of Law of the Aristotle University of Thessaloniki with an "Excellent" grade.

He followed the career of the Judicial Officer of the Military Justice, serving mainly in the positions of Deputy Prosecutor and Prosecutor in the military courts of Athens and Thessaloniki. In this capacity he handled a large number of cases with a wide and varied criminal content. Many of the positions he undertook were widely publicized not only for their scientific significance, but also for their social prominence (for example: the right of the military to express itself freely through the press, the criminal treatment of conscientious objectors and the context of alternative service [these scientific positions have had a positive impact on international organizations], acts of military self-defense, jurisdiction of military courts, the reduction of pre-trial detention with the first adoption of restrictive conditions, defense of social goods, objective delimitation of the attempt, the right to distinction between a criminal and a disciplinary offense, the criminal nature of exceeding the credit balance of a bank ATM). Dozens of his prosecutorial proposals on important criminal matters have been published in legal journals.

In 1992 he was elected assistant professor of the Law Department of the Aristotle University of Thessaloniki. In 1996 he was elected to the rank of associate professor and since 2000 he has been elected full professor of Criminal Law.

He was a member of the Scientific Council of Greek Prisons. He participated in drafting committees of the Ministry of Justice (law on the protection of cultural heritage) and Defense (Organization of military prisons). He also participated in the First Legislative Drafting Committee of a new Code of Criminal Procedure (2005-2009), in the Legislative Drafting Committee for the rationalization and acceleration of criminal proceedings (Nov. 2009 – Mar. 2010) and then in the 2nd Legislative Drafting Committee for the reform of the Code of Criminal Procedure (Apr. 2010 - Oct. 2010).

During the year 2007 he was an alternate member of the Special Court of Cases of article 88 § 2 of the Constitution and of the Special Court for the adjudication of action for miscarriage of justice. He held the same position as a full member in the years 2013, 2017 and 2018. During the period of 2004-2006 he served as Vice President of the Legal Committee of the Aristotle University of Thessaloniki and from 2006 to 2010 as Chairman of the Legal Committee of the University. During the year 2013 he participated as a member of the Judgment Committee and the Review Committee in the criminal law of the Cyprus Council for the Recognition of Qualifications (K.Y.S.ATS). During the academic years 1998-1999, 2005-2006, 2011-2013 2017-2018 and 2018-2019 he was elected Director of the Department of Criminal and Criminological Sciences. During the years 2017 and 2018 he was a member of the Board of Directors of the Society for the Protection of Minors in Thessaloniki. From 2019 until today he is a member of the Study Council of the National School of Judicial Officers for the directions of Civil and Criminal Justice and Prosecutors. He was a member of the Editorial Board of the legal magazine "Yperaspisi" (1991-2000) and today is a member

of the Editorial Board of the legal magazine "Poiniki Dikaiosyni". He is also a member of the "Union of Lawyers of Northern Greece" as well as the "Union of Greek Criminologists". Finally, in the years 2018 and 2019, he was appointed, as a representative of the Law School of the Aristotle University of Thessaloniki, a member of the Central Committee for conducting examinations in the Panhellenic competition for lawyers.

He taught all the courses of his subject (criminal law and criminal procedure), participated in a large number of three-member committees for the preparation of doctoral dissertations (as a supervisor and as a member) and chaired conferences, events and workshops of the Law School, the ESDI and the ENOVE.

He authored and published books of his specialty including:
