Dr. Miltiadis Sarigiannidis is a tenured Associate Professor in Public International Law and the Vice Dean of the Law Faculty of the Aristotle University of Thessaloniki.

He holds a BA (Ptychio) and a DrJur in Public International Law (Law Faculty AUTh), and has obtained a LLM in International Studies (Law Faculty AUTh), a MA in International Conflict Analysis (Department of Politics & International Relations, University of Kent at Canterbury, UK) and a MA in Systematic Philosophy (School of Philosophy & Education, AUTh).

He teaches "Public International Law", "International Protection of Human Rights", "Law of Armed Conflict", "International Institutions", "Law of the Use of Force & Collective Security", "International Relations", and "International Law of the Sea" at the undergraduate and graduate Programme of Studies as well as the Erasmus Programme. He supervises doctoral dissertations and master thesis and coaches students who participate to International Moot Court Competitions and Model United Nations. Furthermore, he has served as the Director of the Sector of International Studies of the Law Faculty and as a member of the Committee of the Department of European Programmes, while currently he is a member of the Assembly of the Law Faculty and a member of the Committee of International Relations of the Aristotle University of Thessaloniki.

He also lectures/ed in various academic and professional institutions around Greece. These include the Department of Political Science of the Democritus University of Thrace, the Department of Language, Literature and Culture of the Black Sea Countries of the Democritus University of Thrace, the School of Economics, Business Administration & Legal Studies of the International Hellenic University, the Hellenic Open University, the Department of Logistics of the Technological Education Institution of Central Macedonia, and the Department of Public Relations and Communication of the Technological Education Institution of Western Macedonia. Moreover, he is a lecturer at the National School of Public Administration and Local Government, the Police Academy/School of Lifelong Education and Training of Northern Greece, the Supreme Joint Command School of War of the Ministry of Defence, and the Multinational Peace Support Operations Training Center of the Ministry of Defence.

He is a member of the Management Board of the EU Fundamental Rights Agency (FRA). In this capacity he has been elected a) member of the FRA Working Group for the Agency's Strategy for the period 2023-2028, and b) member of the Annual Report Editorial Committee (AREDIT). For a decade he participated in the Board of Directors of the Hellenic Society of International Law & International Relations, as a Vice-President, while currently he is President of the Aegean Institute of the Law of the Sea and Maritime Law, and President of the Pontic Research Center of AUTH.

His main research interests focus on the UN legal order, international organization, collective security, the use of force and pacific dispute settlement, humanitarian law, the international protection of human rights, and the Greek foreign policy. He has written monographs, textbooks and publishes in Greek and foreign academic/scientific journals and collective works. He participates to public debates in the field of his expertise by publishing articles to newspapers and digital media and he intervenes with interviews to mass media, both Greek and international.
